

ROBERTSONS SUE PRINCETON UNIVERSITY

A lawsuit has been filed by members of the Robertson family to regain control of the Robertson Foundation, established at Princeton University 42 years ago by Charles and Marie Robertson. William Robertson, son of Charles & Marie, is spearheading the cause. The \$500 million dollar foundation was started by the Robertsons for the Wilson School of Public and International Affairs. The lawsuit alleges that Princeton has abused the fund and ignored the school's mission to train students for careers in government service, using the money for other purposes.

Bill Robertson has stated that his goal is to take control of the Robertson Foundation from Princeton and distribute the money to universities that support his parents' government service agenda to train students for careers "defending freedom worldwide". In June, Superior Court Judge Neil Shuster rejected Princeton's motion to dismiss the case. Look for further details in the newspapers. HFF

OLIVIA WRIGHTSON SWITZ 1908-2003

In this, our twenty-first volume of the H.F.F. newsletter, we celebrate the 95 years of our founder, Olivia Wrightson Switz, who passed away on November 28th at her home in Palm Beach, FL. She was the eldest great-grandchild of George Huntington Hartford, founder of The Great Atlantic & Pacific Tea Co. Born in 1908 in East Orange, NJ, Olivia was the daughter of Josephine Clews and William G. Wrightson. She was a long-time resident of Middletown, NJ and New York City, and has resided in Palm Beach for the past thirteen years. She was predeceased by her brother William G. Wrightson, Jr. in 1989, and her sisters Minnie Wrightson Besch and Cynthia Wrightson Twitchell in 1994.

Olivia studied at Miss Clark's School in East Orange, Miss Beard's School in Orange, and graduated from the Dearborn-Morgan School in 1925. She received her Bachelor's Degree at Smith College, graduating in 1930.

In 1930 she auditioned and was accepted by the Newark Art Theatre, the precursor to the PaperMill Playhouse. She performed in two Broadway shows in the early 1930's, *The Best Years* at the Bijou Theatre and *Jamboree* which opened on Thanksgiving Day, 1932. During World War II, Olivia worked as a Red Cross volunteer in Manhattan, answering inquiries from servicemen's families.

A world traveler and philanthropist, Olivia made significant donations in the early 1970's to The Monmouth County Arts Council, The Monmouth Museum, and Children's Psychiatric Center while living in Monmouth County. She held a seat on the Board of Directors of The Tisch School of the Arts at New York University. She was a member of the Cosmopolitan Club in Manhattan and



numerous private clubs in New Jersey and Palm Beach, FL. She was a long-standing contributor to the Princeton Theological Seminary and a scholarship exists in her name to this day. In Florida, she was a strong supporter of The Unity Church of the Palm Beaches and she served on their Board of Trustees for five years. She also supported mental health programs including Bonnie Brae Farms for troubled boys in NJ and educational institutions including Westchester Community College, located in Valhalla, NY on the former estate of her great Uncle & Aunt, John and Pauline Hartford.



In 1983, Olivia founded The Hartford Family Foundation. In her elder years she felt a responsibility to preserve the history of her family's achievements. She was immensely proud of her success in bringing together a family scattered throughout the U.S. for annual reunions celebrating their mutual heritage. We are happy she lived to see H.F.F. acquire the world's largest collection of A&P memorabilia and publish a book on company and family history. Those of us who have known and loved her cannot express how much Olivia has done to establish H.F.F. as a permanent testimony to the Hartford legacy.

Olivia is survived by her sister and brother-in-law, Martha and Thor Ramsing of Greenwich, CT and Palm Beach; her daughter, Mia Switz Halman of Chapel Hill, NC; her son and daughter-in-law, Sandy and Carol Switz of Jensen Beach, FL; and four grandchildren, Olivia and Will Halman of Chapel Hill, Amelia Switz of Jensen Beach and Ted Switz, who resides in Washington. She has also been an inspiration to numerous nieces, nephews and friends around the country who will miss her sense of humor and generous spirit. ¶¶¶
