THE ROBERTSON FAMILY WILL GET THEIR DAY IN COURT

Led by Bill Robertson, the Robertson family including Anne Robertson Meier and Katherine Robertson Ernst, are suing Princeton University for failing to use the fund established by their parents, Marie and Charles, for the purposes in which it was given. Filed in 2002, Robertson vs. Princeton University is perhaps the largest “donor intent” lawsuit in U. S. history and one of the most important legal cases to affect charitable giving in many decades. The outcome of the lawsuit will likely define “donor intent” in the 21st century.

This past October 25, NJ Superior Court Judge Neil H. Shuster cleared the way for Robertson v. Princeton to go to trial in 2008. The Robertsons have asked the court to remove Princeton from any connection to the Robertson Foundation and its approximately \$880 million endowment. They have also asked the court to order Princeton to return to the Robertson Foundation more than \$200 million in Foundation funds the University improperly diverted to its general fund and to departments unconnected to the Robertson Foundation mission.

In addition, the Robertsons are seeking to recapture the investment return the University earned on the wrongfully diverted funds, estimated between \$300 and \$400 million.

In denying Princeton’s claim that the University was the “sole beneficiary” of the gift, Judge Shuster made it clear that if the family proves egregious and nefarious conduct on the part of Princeton, the court would be warranted in divesting Princeton of its control of and involvement in the Robertson Foundation. “The family believes the evidence of such wrongdoing is overwhelming and looks forward to introducing this evidence at a trial,” said the Robertson family’s attorney, Ronald Malone. **HFF**

H.F.F. PLANS SPRING REUNION

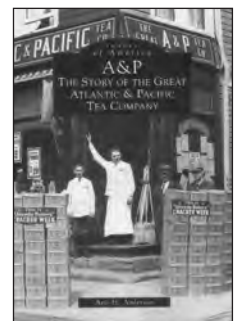

With A&P celebrating it's 150th Birthday in 2009, H.F.F. hopes to join the A&P Historical Society in an exhibition next fall at the Paterson Museum. The Paterson Museum is launching a permanent A&P exhibit. It is also the winter home of the 1928 Ford Model A Produce Truck, shown below. The Historical Society was going to purchase the truck, but Craig Grybowski encouraged A&P management to purchase it for promotional use. "It is not an original A&P vehicle, but we tried to make it as authentic looking as possible with the vintage crates, colors, logos and lettering," says Craig.

The truck was purchased in June and was renovated

just in time for the Ridgewood, NJ Fourth of July Parade. Craig is the truck's designated driver. In addition to the parade, he has taken it to two A&P store Grand-Reopenings and a car show.
